CITY OF SLIDELL COMMUNITY SERVICE AGREEMENT

This agreement is entered into on this _____ day of _____, 2012, by and between Keep Slidell Beautiful, hereinafter referred to as "KSB", and Community Service Worker, hereinafter referred to as "Worker".

The purpose of this Agreement is to provide a means whereby Community Service Workers can contribute toward the effort to maintain litter-free streets, parks, and other areas in the City. KSB will have cleanups between 7:30 a.m. and 11:30 a.m. several days a week.

Workers should check the KSB Website (www.keepslidellbeautiful.org) for up-to-date information, community service opportunities, and dates and times of service. Please do not call the office as we do not return phone calls.

Community Service meets at KSB's new location - 2700 Terrace Avenue. From Old Spanish Trail, turn on Terrace (this is the street that leads to SBBA), and follow the Animal Shelter and KSB signs. KSB is across from the new Animal Shelter building on Terrace Avenue.

KSB will perform the following functions:

1. Provide appropriate bags, safety vests, pickup poles, gloves, etc.
2. Maintain record of work activity performed by Workers and provide copy to Worker.
3. Coordinate the pickup of bags filled with litter after Workers complete their job.
4. The following KSB members are authorized to sign Community Service Work Sheets:

Community Service Workers are required to follow these regulations:

1. Arrive promptly at starting time.
2. Safety First - All participants must wear safety vests during work activity.
3. Anyone 15 years old or younger must be accompanied by a parent or guardian.
4. Wear closed-toed shoes and socks. (No sandals or flip-flops)
5. Wear long pants.
6. No cell phone use, except to contact parents.
7. For safety reasons, no headsets.
8. Bring a water bottle.
9. Return to starting area at 11:30 a.m. (or arranged time) not before.

By my signature, for myself, my estate, and my heirs, I hereby release and discharge, and agree to defend, indemnify and forever hold harmless the City of Slidell, Slidell City Court, Keep Slidell Beautiful, and its organizers, supervisors, officers, directors, agents, volunteers, servants, and employees from any and all causes of action and damages arising from or relating to my participation in this project, and any travel associated therewith, including, but not limited to, claims for personal injury, sickness or loss of limb or life, or property damage, even if said claims arise from injuries or illnesses caused by the sole negligence or fault of those hereby released or third parties.
